

REGULATION GAME AREA

These Regulations govern the methods of access and use of the Game Area. It contains simple but effective rules that aim to guide the child in the game, respecting himself, others and things. To ensure maximum safety and the best service for children, we invite accompanying adults to read the regulation and commit to enforcing it.

THE DIRECTION WILL NOT ACCEPT THE UNKNOWLEDGE OF THE REGULATION AS A JUSTIFICATION

ANTICOVID RULES

- In the event of a queue at the entrance, respect the interpersonal distance as indicated by the signs
- Accompanying adults are invited to self-monitor their health conditions and that of their family. From this point of view, responsible and prudent attitudes are desired
- Accompanying adults and children over 6 years of age must wear a mask
- It is mandatory to maintain at least 1 meter of separation between users, with the exception of members of the same household. The rule also applies to children when using the play structures

- Before entering the Game Area, the accompanying adult and child must compulsorily sanitize their hands with the sanitizing gel placed at the entrance to the Area
- The staff may request the adult and the minor to undergo the detection of body temperature before entering the Area. In the event that the latter is greater than 37.2 °, entry will not be allowed
- Periodic hand sanitization is also highly recommended within the Game Area by using the appropriate dispensers

IT IS STRICTLY FORBIDDEN:

- LEAVE THE CHILD UNATTENDED
- ENTER WITHOUT ANTI-SLIP SOCKS
- ENTER THE PLAYGROUND WEARING SHOES
- INTRODUCE AND USE PERSONAL GAMES OF ANY KIND
- INTRODUCE SHOPPING TROLLEYS, FOOD, BEVERAGES (especially alcoholic) AND ANIMALS
- WEAR GLASSES AND OBJECTS SHARPENED OR POINTED ON GAMES
- TO SMOKE

GAME AREA REGULATION

- The service is free.
- Entrance is allowed for children from 3 to 9 years of age (10 not completed).

- The opening hours and days may change at the Management's discretion.
- Enter inside on the Game Area is allowed only with a green traffic light
- To access the games, the minor must compulsorily store the shoes in the appropriate spaces and wear non-slip socks.
- To allow access, the accompanying adult must fill in the appropriate forms by showing an identification document.
- The maximum stay time is 15 minutes.
- The Management is not liable in the event of interruption of the service due to causes beyond its control.
- The child can access accompanied only and exclusively by 1 accompanying adult.
- During the entire period of stay at Game Area, the minor will remain in the exclusive custody of the parent / carer (however adult), with all the vigilance and attention related obligations and the responsibilities related to any accidents suffered by the minor or the itself caused to other minors and / or third parties and things.
- It is absolutely forbidden to leave minors unattended. In the event that this happens, the Management declines all responsibility.
- Parents cannot enter the play structures.
- It is the faculty of the Management to remove those who do not comply with these regulations or who keep within the Game Area an attitude contrary to hygiene rules or an

offensive and / or contrary to morals language and attitude, which may cause discomfort to other guests.

- The accompanying adults are responsible for the control and actions performed by the accompanying children, therefore any damage to the structure or to the recreational and non-recreational material is always the responsibility of the responsible.
 - Accompanying adults must ensure that children use the games correctly (e.g. keep away, do not jump off the slide, do not throw the games or disperse them).
 - The Management does not keep personal property, therefore it is not liable in case of loss, theft, damage or deterioration of objects brought into the Game Area.
- Any information signs posted, or communicated through other channels, form an integral part of these regulations.
- Access to the Game Area presupposes acceptance of the regulation in all its parts, which can be modified by the Management by means of posted notices.
 - The acceptance of the regulation will take place by signing the entry form.
